**Amended Constitution of**

**R.M. Educational Trust Kota (Rajasthan)**

1- **Establishment of Trust** :- Dr. Zafar Mohd. S/o Sh. Rasool Mohd. Aged 57 years residing at 29, behind All India Radio, Akashwani Colony, Kota hence-forth called the SETTLER, owns and possessed a sum of Rs 50,000/- (Rs. Fifty Thousand Only) which is his own property and over with he has full disposing power under the law (hereinafter referred to said sum). At present he desire to create a public charitable trust by setting the aforesaid sum Rs. 50,000/- (Rs. Fifty Thousand Only) for public purpose in India.

    - Dental College** : BDS, MDS, etc.

j) **University** : To establish, support, upgrade, maintain, run private universities with UG/PG courses in all faculties with an objective to provide university level education to students etc.

(ii) The emphasis will be on education. It is further specifically provided that the object contained aforesaid namely education, shall not involve carrying on of any business or activity for profit, the benefit of this trust shall be open to all irrespective of caste, religion, sex etc. and its activity shall not be confined to India but also in abroad.

(iii) To print , publish, purchase, sell, circulate, distribute or exhibit either free or for a price, - books, periodicals, journals, booklets, bulletins, calendars, message-cards, other literature, films, documentaries, records, paintings and photographs which will assist or promote the objects of the Trust.

(iv) To arrange and organize lectures, debates, discussions, study tours, conferences, or radio-talks for the advancement of the objects of the Trust.

(v) To organize and run residential educational school, college, professional, physical, medical, technical programme.

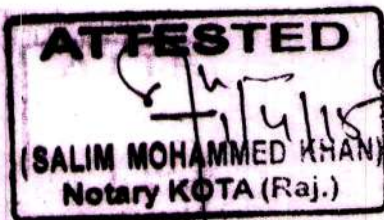
(vi) To establish Training Centre and allied educational institutions.

(vii) To establish and develop educational institutions for the physically handicapped & disabled or mentally retarded person.

(viii) To develop required infrastructure, buildings and other assets necessary to carry out the objects of this Trust

(ix) To engage, employ or hire appropriate staff, workers, legal experts and other professionals, attorneys, managers and agents to look after the work and for furtherance of aims and objects of the Trust and to pay their wages, salaries, stipends or fees etc.

(x) To set up various committees for looking after the work and for furtherance of aims and objects of the Trust.

- (i) That in order to implement his desire, the SETTLOR has transferred and handed over the said sum of Rs. 50,000/- (Rs. Fifty Thousand Only) to the TRUSTEES and he does hereby confirm such payment and handing over unto the TRUSTEES on irrevocable trust to be used exclusively for public purpose {as defined in section 2 (15) of the Income Tax act, 1961 and/or other law as applicable} which are also more particularly specified hereinafter in the objects of this deed and with & subject to the powers, conditions, provisions and declaration contained in and concerned with the Trust.
- (ii) That the Trustees do hereby declare that they shall hold and stand possessed of the said sum of Rs. 50,000/- (Rs. Fifty Thousand Only) together with such additions and accretions there to as may be made by donations, gifts and income and/or otherwise (the whole of which is hereinafter referred to as "TRUST PROPERTY OR TRUST FUND") which expression shall also include any other cash, investments or securities assets and property, additions and accretions there to or any part thereof might be converted from time to time upon the said trust subject to the aid powers conditions and provisions hereinafter

**7- Trustees:-**

(a) **Patron Trustees:-**

The following shall be the FIRST FOUNDER PATRON TRUSTEES and shall form part of the Trust Board.

- (i) Dr. Zafar Mohd. S/o Rasool Mohd., age 57 year occupation Business, address 29, Behind All India Radio Akashwani Colony, Kota (Raj.)
- (ii) Mrs. Naseem Bano W/o Dr. Zafar Mohd., age 54 year address 29, Behind All India Radio Akashwani Colony, Kota (Raj.)
- (iii) Dr. Parvez Khan S/o Dr. Zafar Mohd., age 34 year address 29, Behind All India Radio Akashwani Colony, Kota (Raj.)
- (iv) Mr. Zuber Khan S/o Dr. Zafar Mohd., age 29 year address 29, Behind All India Radio Akashwani Colony, Kota (Raj.)



Each FOUNDER PATRON TRUSTEE shall be entitled to nominate a representative in his place to the Trust Board. The FOUNDER PATRON TRUSTEES shall be Hereditary.

Any person who donates a sum of Rupees to be decided by the Trust Board shall be entitle to become a PATRON TRUSTEE. The number of PATRON TRUSTEES shall not be exceed 10.

**(b) Whole Life Trustees:-**

Any person who donates a sum Rupees to be decided by the Board of Trust shall be entitle to become a whole Life Trustee. A whole Life Trustee shall be Trustee for his life or 25 years whichever is higher. Incase of his death the nominee will continue as life member for the remaining period out of 25 years. The president shall be elected from PATRON TRUSTEES to be elected by the Board of Trustees. This pattern shall be followed in future for electing the President.

**(c) Trustees:-**

The Board of Trustees with the approval of Parton Trustees (Special resolution 75% or more favorable voting) shall be at liberty to appoint/associate the name or names of any person or persons as Trustee with or without a sum of rupees on the terms & conditions as shall be decided by the Board of Trustees at the time of appointment/ associate.

**(d) Vacate Post of Trustees:-**

The Trustee shall hold his office for the duration as mentioned above. However his office shall be vacated if:-

- i) He tenders his resignation in writing or
- ii) He is adjudged as an insolvent, or
- iii) He is found to be of unsound mind by a court, or
- iv) He acts in any manner prejudicial to the interest of the TRUST or is otherwise guilty of breach of trust, as per the decision of the remaining trustees.
- v) He is asked in writing to resign unanimously by the remaining Trustees.

- (e) That the Trustees will be entitles to honorarium or reasonable remuneration for their services or work actually rendered to the Trust in carrying out the object and purpose of the Trust and to reimburse themselves for all the expenses actually incurred or spent by them in connection with the Trust or affairs of the trust or their duties relating thereto.

**8- MANAGING TRUSTEE:-**

The Trust shall be managed by Board of Trustees consisting of ALL THE TRUSTEES. However to the control, supervision and to look after the day-to-day affairs and administration of the Trust Dr. Zafar Mohd. Shall be the Managing Trustee for whole life. However after his death, the continuing Patron Trustee shall be appoint a Managing Trustee. The Managing Trustees shall be manage the Trust for regular activities, its properties and funds and shall have all necessary powers and authorities for that purpose.

The Managing Trustee shall have liberty to associate the name and names of any person or persons as Secretary, Treasurer etc. for prescribed tenure to take assistance to look after day to day work.

**9- POWER OF TRUSTEES:-**

**THE TRUST BOARD SHALL HAVE POWER:-**

- (i) To make use of the Trust property including income of the Trust Corpus or any part thereof for all or any of the objects, of these presents.
- (ii) To accept donations, contributions and gifts either in cash for in from any person on such terms and conditions which are in conformity with the objects and purposes of this Trust by associating the name of such person's as the Trust Boards in its absolute discretion shall deem fit.
- (iii) To purchase, acquire, exchange, take on lease or mortgage and sell land and immovable properties and to construct buildings and to repair renovate and develop any immovable property for the purposes of the Trust. To purchase, acquire, take on lease or hire and sell any movable properties, including furniture, fixtures, books, conveyance for the purposes of the Trust.

To permit the use and occupation of any immovable or movable property of the trust on such terms and conditions as the Trustees may deem fit.

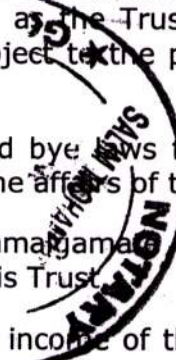

- (v) To appoint committees, advisory boards, Governing body for any institutions established, run and maintained by the Trust and the members of such committee may include persons not exceeding 5, who may not the trustees of the Trust.
- (vi) To open and one fate account with banks and to negotiate endorse securities cheque and negotiable instruments.
- (vii) To prosecute, sue and defend all action at law and to offer in arbitration and accept award and to compromise or forgo any claim by the Trust.
- (viii) To borrow or raise money for the purposes of the Trust and to repay the same. To invest the surplus funds of the Trust in the name of the Trust as the Trustees in their absolute discretion shall deem fit, subject to the provision absolute of the Income Tax Act. 1961.
- (ix) To make Rules and bye laws for the proper management and administration of the affairs of the Trust.
- (x) The accept or to amalgamate with it, any Trust which has the object similar to this Trust.
- (xi) To accumulate the income of the Trust and to amalgamate the same with the corpus of the Trust and any income of the Trust no spent in a year shall unless otherwise determined by the Trust Board be deemed to be accumulated. This power of the Trust Board shall always be subject to the relevant provisions to the Income Tax Act, 1961 as amended from time to time.
- (xii) To apply to the Government, public bodies, urban, local, municipal, district and other bodies, corporation, companies, or persons for and to accept grant or moneys, aid donations, gifts, subscriptions and other assistance with a view to promoting the objects of the Trust and to discuss and negotiate with the Government department, public and other bodies, corporations, companies or persons schemes and other word matters within the object of the Trust and to confirm to any proper condition upon which such grants and other payments may be made.
- (xiii) To establish, promote, manage, organize or maintain or to assist in establishing, promoting, managing, organizing or maintaining any branch of the Trust or any other trust or its branch with objects similar to those of this Trust and to promote or carry on the affiliation or amalgamation of such other Trust with this Trust.

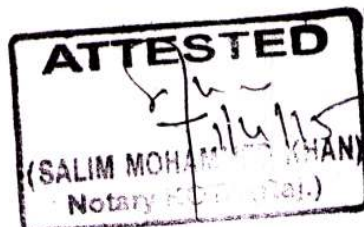

- (xiv) To take over, acquire, manage, control or aid any existing institution or institutions having object either wholly or in part similar to the objects of this Trust and on such terms and conditions as may be thought expedient by the Board of Trustees.
- (xv) To Purchase or otherwise acquire and undertake all or any part of the property, assets, liabilities, and engagement of any one of more of the Trust, societies, institutions of associations with which this trust in authorized to amalgamate.
- (xvi) To transfer all or any part of the property, assets, liabilities and engagements of this Trust to any one or more of the Trust, societies, institution or associations with this Trust is a horsed to amalgamate.
- (xvii) And generally to do all others acts, deeds and things as are necessary, conductive suitable identical or incidental to or for the attainment of the above objects or any them.
- (xviii) The Trust Board shall have the power to determine in case of doubt whether any moneys or property shall for the purpose of the charity be considered as capital or income and whether out the income or capital any expenses or outgoing doubt to be paid or borne and every such determination shall be binding and conclusive provided that nothing contained shall be deemed to authorize the Trustees to spend the income or corpus of the Trust for any purpose not authorized by these presents.
- (xix) Trust Board shall be with a three fourth of majority be at liberty to amend/modify the provisions of this Indenture including objects, clauses and to execute necessary documents in connection therewith if so required by the Trust Board or any authorities prescribed under the law for the time being in force, subject to the approval and confirmation by the I.T. Authorities.
- (xx) To clear any ambiguity as to the interpretation of any of the provisions of this deed, it shall be lawful for the Board of Trustees to decided the same such decision shall be final.

**10- MEETING :-**

- (i) That the Board of Trustees shall from time to time frame rules for the conduct and regulation of the Trust meetings and taking minutes of the meeting of the Trustees along with election of the member of Trust Board.
- (ii) That the president shall be the Chairman of the BOARD OF TRUSTEES. The President/ Chairman shall have power to appoint someone Patron Trustee as Vice Chairman in the absence of the Chairman, The Vice-Chairman shall be Chairman of the meeting and in the absence of both at any meeting the Trustees who may be present at the meeting shall elect a Chairman of that meeting.
- (iii) That the 1/3<sup>rd</sup> of the total number of Trustees or 2 Trustees whichever is higher shall form a quorum for a meeting of the Trust Board.
- (iv) That there would be one Annual General meeting every year within a period of 6 month after the closing day of the Final Account (i.e. up to 30<sup>th</sup> September), all other meeting shall be considered as Board meeting and / or extra ordinary general meeting.
- (v) All the matters shall be decided mutually by the Trustees by majority in the event of equality of votes, the President should have a casting vote.
- (vi) That Resolutions may be passed without holding a meeting of the Trust Board out by circulation thereof and evidenced in writing the proposed resolutions which must be endorsed by the two third of the Trust Board. If resolutions are endorsed in this manner they shall be as valid and effectual as a resolution duly passed at the meeting of Trust Board.
- (vii) That the Trustees shall keep or cause to be kept a minute books to record the proceedings of the meeting of the Board of Trustees.

**APPLICATION OF TRUST PROPERTY/ INCOME :-**

- (i) It is expressly declared that part of the Trust Property or the income of the Trust shall be applied for expansion of educational institute or for any purpose which is not a charitable purpose in law and all provisions hereof shall be construed accordingly.
- (ii) The Trust property and the Trust fund shall be and remain irrevocable.
- (iii) The Income and property of the Trust howsoever derived shall be applied solely toward the promotion of the objects of the Trust as set-forth above and no portion thereof shall be paid or transferred directly or indirectly by way of profits dividend and bonus or otherwise whatsoever to any person, who are members for the Trust or persons who at any time have been members of the Trust or to any of them or any persons claiming through any of them provided that nothing herein contained shall prevent the payment in good faith to any servants or employees of the Trust in return for the service rendered to the Trust. It shall be lawful for the Trustees for the time being of this Trust to reimburse themselves or himself or pay or discharge out of the Trust fund all expenses incurred in or about the execution of the Trust matters.
- (iv) It shall be absolutely in the discretion of the Trustees to decide from time to time as to for which objects and purposes specified above the entire corpus of the Trust or net income of the Trust property or portion or portions of either shall be utilized, paid or spent by them and also to the terms, conditions, durations, and manners in which the same be so utilized, paid or spent.
- (v) If any persons at any time hereafter offers to add to the corpus fund hereby settled whether by transfer of any immovable or movable property or of Government or other securities or payment of cash in aid of any of the objects of the Trust hereby established. it shall be lawful for the Trustees to accept the same upon such terms and conditions not inconsistent with the objects of the Trust hereby constituted as the said Trustees may determine provided that in no case shall be name of the Trust hereby created be altered in any manner whatsoever or its declared aims and object departed from. and upon such receipt, the same shall form part of the Trust fund and the provisions here in above shall apply accordingly.

- (vi) All securities and investment which may at any time to vested or belonging to the Trust shall stand in the same of the Trust.
- (vii) The Trustees may open, operate and maintain accounts with one or more banks in the name of the Trust. Such accounts shall be operated by any two office bearers jointly and one of the two shall be the President.
- (viii) The Trustee or Trustees for the time being of this Trust shall be chargeable only for such moneys, stocks, funds and securities as they shall actually receive, notwithstanding their signing any receipt for the make of conformity and shall be answerable and accountable only for their own acts, receipts, neglects or defaults and not for those of each other or for any bankers of other persons with whom any Trust moneys or securities may be deposited, not for the insufficiency or deficiency of any stocks, funds or securities nor for any other loss unless the same shall happen through their own willful default.
- (ix) The investments of funds of the Trust will be in accordance with the provision of section 13(1)(d) read with section 11(5) of the I.T. Act, 1961.

**12. FINCANCE AND ACCOUNTS :-**

- (i) It shall be lawful for the Trust board to settle all accounts and to compromise, compound, abandon, or refer to arbitration any action or proceedings to disputes claim, demand or things, proper for such purpose without being responsible for any loss occasioned thereby.
- (ii) It shall be lawful for the Trustees to borrow moneys either on the security of any property comprised in the Trust fund or otherwise for all or any of the purpose of these presents and it shall be lawful for the Trustees to make such borrowings on payment of such interest and otherwise on such terms and conditions as they may in their absolute discretion think fit.
- (iii) The Trustees shall maintain regular accounts of the receipts and expenditure of the Trust and that the accounting year of the Trust shall be the financial year i.e. from 1<sup>st</sup> April to such year to the 31<sup>st</sup> March of the next year. The first of such account will be closed on 31.03.2002 and every year the accounts shall be audited by Chartered Accountant appointed by the Trust Board.

**13. AMALGAMATION :-**

In case of the dissolution or determination which shall be affected by the consent of all the patron Trustees and three-fourth majority of the balance Trustees of the time being and in that event the Trust fund after discharging all the liabilities and outgoing of the Trust shall be handed over or transferred by the Trustees to any other Trust or any other body or institution having similar objects as the Trustees may deem fit and proper.

**14. CHANGE IN CONSITUTION OF TRUST :-**

As the necessity the Trusty board will be empowered to change and amend the constitution of Trust by majority of general body of the Trustees.

**15. JURISDICTION TO FUNCTION AND OF DISPUTES :-**

- (i) The Trust shall be authorised to function throughout India & abroad.
- (ii) In case of any legal disputes, claims, or litigation within the jurisdiction of the law arise they will only be considered valid if they are lodged with in the precincts of Kota Rajasthan.

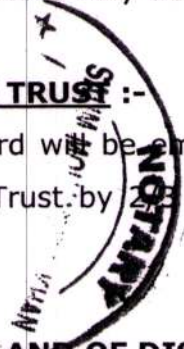
